The Stewards hereby impose the following penalty:

Having waived her right to a hearing, Trainer Rachael Maddox is hereby fined one thousand two hundred fifty dollars (\$1,250.00) for violation of WV Rule of Racing 178-1-49.4.a.2.

Industrial Laboratories reported sample E274459 taken from the horse "Kara Lot" which finished 1st in the 7th race on Wednesday, June 27, 2018, did contain Dexamethasone and Phenylbutazone above the legal threshold. The Dexamethasone was quantitated at the level (85.0 pg/ml) and the Phenylbutazone was quantitated at a level of (2.8 ug/ml). Ms. Maddox elected not to send a split sample.

Ms. Maddox is assessed one-half (1/2) point for the Dexamethasone violation and one-half (1/2) point for the Phenylbutazone violation for a total of one (1) points under the Multiple Medication Violations.

The horse "Kara Lot" is disqualified from all purse monies and the purse is to be redistributed as follows:

- 1.) Gingerbread Lady
- 2.) Calimonco's Heart
- 3.) Fred's Golden Girl
- 4.) Beautiful B
- 5.) Little Lies
- 6.) Miz Machen

The horseman's bookkeeper is requested to make the necessary adjustments.

All fines imposed by the stewards shall be paid to the Racing Commission within 7 days after the ruling is issued, unless otherwise ordered by the Stewards, per WV Rule of Racing number 178-1-8.5.n.





After a review in the jock's room, Jockey Luis Quinones is hereby suspended for three (3) Mountaineer Park race days for violation of WV Rule of Racing, section (s) 178-1-45.7.b.1, 178-1-45.7.c.3 and 178-1-45.7.c.1. Mr. Quinones' days of suspension will begin Tuesday, August 7, 2018, Wednesday, August 8, 2018 and Sunday, August 12, 2018. Mr. Quinones is permitted to ride in other jurisdictions on August 9, 10 and 11, 2018.

"A jockey shall not ride carelessly or willfully so as to permit his or her mount to interfere with, impede or intimidate any other horse in the race."

"If the Stewards determine that a foul was intentional, due to careless riding, the jockey may be held responsible and his or her permit may be disciplined."


"When the way is clear in a race, a horse may be ridden to any part of the course, but if any horse swerves, or is ridden to either side, so as to interfere with, impede or intimidate any other horse, it is a foul."

After a review the Board of Stewards determined that #2 "Abandoned" ridden by Luis Quinones did drift out causing interference with #4 "Cobra Kid" in the stretch running of the 3rd race on Monday, July 30, 2018.


As per WV Rule of Racing 178-1-28.1.f, Mr. Quinones is permitted to gallop while under suspension.

All fines imposed by the stewards shall be paid to the Racing Commission within 7 days after the ruling is issued, unless otherwise ordered by the Stewards, per WV Rule of Racing number 178-1-8.5.n.

The Stewards hereby impose the following penalty:

A hearing was telephonically convened on Monday, August 13, 2018 for trainer Santiago Medina regarding allegations set forth in a notice of hearing issued August 6, 2018. After considering all testimony and evidence, the Board of Stewards hereby find the following:

Industrial Laboratories reported sample number E234186 taken from the horse "Jennysregalman," which finished 1st in the 7th race on Sunday, June 3, 2018 did contain Clenbuterol (approximately 2.40 pg/ml) confirmed in serum and Phenylbutazone (approximately 4.23 ug/ml) confirmed in serum, above the legal threshold. Clenbuterol is a class 3 drug carrying a B penalty and Phenylbutazone is a class 4 drug carrying a C penalty. A split sample was sent to Analytical Toxicology Lab, Reynoldsburgh, Ohio, which confirmed the presence of Clenbuterol in serum. Mr. Medina did not send a split sample for the Phenylbutazone.

The Board of Stewards concludes that Mr. Medina has violated section 178-1-49.4.a.2 of the Thoroughbred Racing Rule, 178 C.S.R.1. This medication/prohibited substance violation is the permit holders 1st offense in a 365 day period for a medication/substance violation carrying a category (A) and a category (C) penalty. The permit holder has accumulated zero (0) points under the multiple medication violation point system prior to this ruling. The points assessed for this medication/substance violation are two (2) points for the Clenbuterol and one-half (1/2) points for the Phenylbutazone, giving a total of two and one-half (2 1/2) points pursuant to section 178-1-49.3.m of the Thoroughbred Racing Rules.

The penalty guidelines set for in table 178-1E of the Thoroughbred Racing Rules provide a minimum penalty of fifteen (15) days suspension and a five hundred dollar (\$500.00) fine for the Clenbuterol violation and a two hundred fifty dollar (\$250.00) fine for the Phenylbutazone violation.

Based on the above, the Board of Stewards hereby fine Mr. Medina seven hundred fifty dollars (\$750.00) along with a fifteen (15) day suspension. The suspension shall start on Sunday, August 19, 2018 through and including Sunday, September 2, 2018.

The following is the Stewards' analysis of the mitigating/aggravating factors in this matter:

A.) The permit holder's past record

The permit holder had no positives in the past 4 years

B.) The potential of the drug to influence the horse's racing performance.

Drugs in this class may or may not have an accepted therapeutic use in the horse. Many are drugs that affect the cardiovascular, pulmonary and autonomic nervous system. They all have the potential of affecting the performance of a racehorse.

C.) The legal availability of the drug.

Legal by prescription

D.) Whether there is reason to believe the permit holder knew of the administration of the drug or intentionally administered the drug.

Trainer says he has knowledge of the drug.

E.) The steps taken by the trainer to safeguard the horse.

Trainer has stalls at the racetrack. No extraordinary measures taken to safeguard the horse.

F.) The probability of environmental contamination or inadvertent exposure due to human drug use.

There is a possibility.

G.) The purse of the race.

\$6,300.00

H.) Whether the drug found was one for which the horse was receiving a treatment as documented by the treating veterinarian's treatment records.

The horse was being treated by a veterinarian for this drug.

I.) Whether there was any suspicious betting pattern in the race.

None

J.) Whether the trainer was acting under the advice of a veterinarian licensed to practice in West Virginia and holding an occupational permit issued by the Racing Commission.

The trainer administered these drugs.

K.) Other factors deemed relevant by the Stewards.

The trainer has established a very respectful training career.

The horse "Jennysregalman" is disqualified from all purse monies and the purse is to be redistributed as follows:

1st) Merengon

2nd) Pure Trust




Mr. Cordero-Lopez failed to have a published work in the racing office for the horse "Gran Alegria" in the 2nd race on Tuesday, October 2, 2018, necessitating a late scratch. This is his first offense.

All fines imposed by the stewards shall be paid to the Racing Commission within 7 days after the ruling is issued, unless otherwise ordered by the Stewards, per WV Rule of Racing number 178-1-8.5.n.

You have the right to appeal this ruling to the Racing Commission. Your appeal must be received in the Commission Office within 20 days of your receipt of the ruling and must include a security fee in the amount of \$500.00.
