This is his first medication violation and he is assigned two (2) points for the Multiple Medication Violation System.

The horse "Magic Sparkle" is disqualified from all purse monies and the purse is to be redistributed as follows:

- 1st) Pleasant Outlook
- 2nd) Confection Fortune
- 3rd) Super Echelon
- 4th) Overcriticized
- 5th) Go Harley Go
- 6th) Stew Boy
- 7th) Aggravator
- 8th) Limit Your Loses
- 9th) True Honor

The horsemen's bookkeeper is requested to make the necessary adjustments.



The Stewards hereby impose the following penalty:

Industrial Laboratories reported sample #E335437 taken from the horse "Heart in Hand" which finished 1st in the 1st race on Sunday, August 4, 2019 did contain Ketoprofen confirmed in blood at 7.87 ng/ml. Ketoprofen is a class 4 drug carrying a C penalty.

Mr. Jimenez waived his right to a hearing and elected not to send a split sample. The Board of Stewards concludes that Mr. Jimenez has violated section 178-1-49.4a.2 of the Thoroughbred Racing Rules 178 C. S. R. 1. This medication/prohibited substance violation is the permit holders first offense in a 365 day period for medication/prohibited substance carrying a category C penalty. The permit holder has accumulated zero points under the multiple medication violation point system prior to this ruling. The points assessed for this violation are one half (1/2) points giving a total of one half (1/2) points pursuant to section 178-1-40.3.m of the Thoroughbred Racing Rules.

Based on the guidelines set forth in table 178-1 of the Thoroughbred Racing Rules, the Board of Stewards hereby fine Mr. Jimenez two hundred fifty dollars (\$250.00).

All fines imposed by the stewards shall be paid to the Racing Commission within 7 calendar days after the ruling is issued, unless otherwise ordered by the Stewards, per WV Rule of Racing number 178-1-8.5.n. After 7 days all permits will be suspended without notice until fines have been paid.







Industrial Laboratories reported that sample # E335440 taken from the horse "Flash K" which finished 1st in the 5th race on Sunday, August 4, 2019 did contain Clenbuterol, a class 3 drug carrying a B penalty, confirmed in urine at a concentration level of 751 pg/ml.

The permit holder has accumulated two (2) points under the multiple medication violation point system prior to this ruling. The points assessed for this medication/substance violation are zero giving a total of two (2) points under the Multiple Medication Violations. Mr. Urbaneja had a first offense positive for Clenbuterol on Sunday, July 28, 2019. As per WV Rule of Racing 178-1-49.3.m.3 this positive incurred prior to delivery of official notice by the Stewards and is being treated as a single violation.


The horse "Flash K" is disqualified from all purse monies and the purse is to be redistributed as follows:
