



The Stewards hereby impose the following penalty:

Industrial Laboratories reported sample #E337378 taken from the horse "I'm a Lawman" which finished 1st in the 4th race on Sunday, September 8, 2019 did contain Ketoprofen confirmed in blood (63.8 ug/ml The measurement uncertainty at the threshold is +/- 0.2 ng/ml at the 0.2 ng/ml threshold). Ketoprofen is a class 4 drug carrying a C penalty.

Mr. Capellini waived his right to a hearing and elected not to send a split sample. The Board of Stewards concludes that Mr. Capellini has violated section 178-1-49.4.a.2 of the Thoroughbred Racing Rule, 178 C. S. R. 1. This medication/prohibited substance is the permit holders first offense in a 365 day period for medication/prohibited substance violation carrying a C penalty. The permit hold has accumulated zero (0) points under the multiple medication violation point system prior to this ruling. The points assessed for this medication/prohibited substance violation are one-half (1/2) points pursuant to section 178-1-49.3.m of the Thoroughbred Racing Rules.

Based on the guidelines set forth in 178-1 of the Thoroughbred Racing Rules, the Board of Stewards hereby fine Mr. Capellini one thousand dollars (\$1,000.00).

The horse "I'm a Lawman" is disqualified from all purse monies and the purse is to be redistributed as follows:



Industrial Laboratories reported sample #E337433 taken from the horse "Big Premier" which finished 1st in the 5th race on Monday, September 9, 2019 did contain Methylprednisolone confirmed in blood (412 pg/ml). Methypresnisolone is a class 4 drug carrying a C penalty.

Ms. Langley waived her right to a hearing and elected not to send a split sample. The Board of Stewards concludes that Ms. Langley has violated section 178-1-49.4.a.2 of the Thoroughbred Racing Rule, 178 C. S. R. 1. This medication/prohibited substance is the permit holders first offense in a 365 day period for medication/prohibited substance violation carrying a C penalty. The permit hold has accumulated zero (0) points under the multiple medication violation point system prior to this ruling. The points assessed for this medication/prohibited substance violation are one-half (1/2) points giving a total of one-half (1/2) points pursuant to section 178-1-49.3.m of the Thoroughbred Racing Rules.

Based on the guidelines set forth in 178-1 of the Thoroughbred Racing Rules, the Board of Stewards hereby fine Ms. Langley one thousand dollars (\$1,000.00).
