The Stewards hereby impose the following penalty:

Industrial Laboratories reported sample #E338073 taken from the horse "Hotspur Harriet" which finished 1<sup>st</sup> in the 8<sup>th</sup> race on Sunday, June 7, 2020 did contain Phenylbutazone confirmed in blood (3.5 ug/ml.) The measurement uncertainty is +/- 0.4 ug/ml at the 2 ug/ml threshold. Phenylbutazone is a class 4 drug carrying a C penalty.

Mr. Treharne waived his right to a hearing and elected not to send a split sample. The Board of Stewards concludes that Mr. Treharne has violated section 178-1-49.4.a.2 of the Thoroughbred Racing Rule, 178 C.S.R.1. This medication/prohibited substance violation is the permit holders second violation in a 365-day period for medication/prohibited substance carrying a C penalty. The permit holder has accumulated (3) three points under the multiple medication violation point system prior to this ruling. The points assessed for this medication/prohibited substance violation are (½) one-half, giving a total of (3 ½) three and one-half points pursuant to section 178-1-49.3.m of the Thoroughbred Racing Rules.

Based on the guidelines set forth in table 178-1 of the Thoroughbred Racing Rules, the Board of Stewards hereby fine Mr. Treharne \$500.00 (five hundred) dollars.

All fines are to be paid within seven (7) days of imposition as per West Virginia Rule of Racing

178-1-8.5.N.

Industrial Laboratories reported sample #E338057 taken from the horse "I'm So Munny" which finished 1<sup>st</sup> in the 3<sup>rd</sup> race on Monday, June 1, 2020 did contain Flunixin confirmed in blood (13.2 ng/ml.) The measurement uncertainty is +/- 0.5ng/ml at the 3 ng/ml threshold, Phenylbutazone confirmed in blood at (0.926 ug/ml.) The measurement uncertainty is +/- 0.049 ug/ml at the .03 ug/ml threshold. These two drugs constitute a class 3 NSAID Stacking Violation (Penalty Class C, fines only.)

Mr. Cordero Lopez waived his right to a hearing and elected not to send a split sample. The Board of Stewards concludes that Mr. Cordero Lopez has violated section 178-1-49.6.c.3.a of the Thoroughbred Racing Rule, 178 C.S.R.1. This medication/prohibited substance violation is the permit holders first violation in a 365-day period for medication/prohibited substance carrying a C penalty. The permit holder has accumulated (0) zero points under the multiple medication violation point system prior to this ruling. The points assessed for this medication/prohibited substance violation are (½) one-half, giving a total of (½) one-half points pursuant to section 178-1-49.3.m of the Thoroughbred Racing Rules.

Based on the guidelines set forth in table 178-1 of the Thoroughbred Racing Rules, the Board of Stewards hereby fine Mr. Cordero Lopez \$1,000.00 (one thousand) dollars.

The Stewards hereby impose the following penalty:


Having waived his right to a hearing, Owner/Trainer Jake Radosevich is hereby fined two hundred fifty dollars (\$250.00) for violation of WV Rule of Racing 178-1-49.4.a.2.

Industrial Laboratories reported sample E338252 taken from the horse "Big Game Bob" which finished 2<sup>nd</sup> in the 1<sup>st</sup> race on Tuesday, June 28, 2020 did contain Phenylbutazone confirmed in blood at 5.0 ug/ml. Phenylbutazone is a class 4 drug carrying a C penalty. Mr. Radosevich elected not to send a split sample.

This medication/prohibited substance violation is the permit holders first offense in a 365-day period for a substance carrying a C penalty. The permit holder has accumulated four (4) points under the multiple medication point system prior to this ruling. Mr. Radosevich is assessed one-half (1/2) points for this violation under the multiple medication point system giving him a total of four and one-half (4 ½) points.

All fines imposed by the stewards shall be paid to the Racing Commission within 7 days after the ruling is issued, unless otherwise ordered by the Stewards, per WV Rule of Racing number 178-1-8.5.n.


The Stewards hereby impose the following penalty:



Mr. Flores failed to give his best effort on the #5 "Change From Within" during the running of the 5<sup>th</sup> race on Monday, July 19, 2020.


This is Mr. Flores first violation of the year.


As per WV Rule of Racing #178-1.1.f, Mr. Barrios is permitted to gallop during his suspension.
