### **WV Racing Commission Conference Room**

The WV Racing Commission met on January 23, 2024, to conduct business and consider administrative matters. Roll call was taken, and present were Chairman Ken Lowe Jr. and Commissioner Chip Urling.

### Agenda Item #1 - Annual Election of Chairman

Joe Moore presented the motion that Commissioner Lowe remain the The West Virginia Racing Commission Chair for the year 2024. Commissioner Urling request this motion and is second by Commissioner Lowe. The West Virginia Racing Commission is glad to elect Chairman Ken Lowe as returning Chairman for 2024, and he humbly accepts.

This also has 16 stakes races that have had the purse supplemented by the WTDF like in years past with 50,000 and also supplemented 25,000 per race from the purse fund. This is in agreement with the Charles Town HPPA. Charlie is excited about the race schedule and the three graded races. He mentions that they have been examining the American Grade sheet and feel like these stakes races have the best upward mobility.
