

Raines and Imark Kennels Dispute

On Thursday 1/19/23 I was notified by Wheeling Island Presiding Judge, Ralph Brehm, that there were ongoing heated escalating issues between employees from the Imark and Raines kennels.

On the morning of Monday 1/23/23 I visited the kennel compound, walked the premises and spoke with members of both kennels. Joel Roden and Amanda McCardle with Raines kennel indicated that Amanda was being harassed at the kennel compound and racetrack by DiAnn Derr, Aubrey Derr and Anna Jarrett, employees of Imark kennel. McCardle said the Imark employees were harassing her about where she was parking at the kennel as well as mouthing things at her and touching her equipment at the racetrack, accusing her of hanging muzzles in their way etc. Roden indicated that one of the Imark employees purposely blocked his kennel truck at the kennel so he could not get out to haul dogs to the track. Both Roden and McCardle said the Imark girls are just mean and spiteful and insisted neither of them had done anything wrong and nothing to aggravate the Imark employees. DiAnn Derr with Imark accused McCardle of purposely and repeatedly parking in the mornings in front of their kennel with the headlights of her car shining directly into the turnout area as well as having the radio playing loudly. Derr

said McCardle thinks because she works for Raines kennel that she's special and can do what she wants. Derr said that McCardle also gets away with not following rules at the track because of her close relationship with the State Veterinarian, Dr. Bohenko. When asked about possibly blocking the Raines kennel truck Derr said not only was that not true but that actually their kennel truck had been blocked by someone from Raines kennel, presumably McCardle. Derr insisted that none of the employees at Imark had done anything wrong and that the only antagonist was McCardle. Aubrey Derr and Anna Jarrett supported DiAnn's statements.

On the morning of Thursday 1/26/23 I visited the kennel compound and then the racetrack. Employees from both kennels said relations were ok because each was just avoiding the other, but neither thought civility would continue.

Today, Tuesday 1/31/23 I visited the kennel compound to get employee rosters and an update on the kennel relations. Being a dark day and the compound covered in ice it was quiet.

The significant individuals involved in this dispute can be listed as Amanda McCardle, DiAnn Derr, Aubrey Derr, and Anna Jarrett, with Joel Roden supporting McCardle but not being accused of anything by Imark.

with the wrong tag. Mr. Armstrong waived his right to a hearing and pleaded guilty.


The Judges conclude that the conduct of Blane Armstrong
