Industrial Laboratories reported sample #E531200 taken from the horse "Topsy Rose Lee" which finished 1st in the 7th race on Sunday, September 15, 2024, did contain Dexamethasone confirmed in blood at (25.1 pg/ml.) The measurement of uncertainty of the method is (0.76 pg/ml) at the threshold of (5 pg/ml.) Dexamethasone is a class 4 drug carrying a C penalty.

Mr. Fiesman waived his right to a hearing and elected not to send a split sample. The Board of Stewards concludes that Mr. Fiesman has violated section 178-1-49.4.a.2 of the Thoroughbred Racing Rule, 178 C.S.R.1. This medication/prohibited substance violation is the permit holder's first offense in a 365-day period for medication/prohibited substance carrying a C penalty. The permit holder has accumulated zero (0) points under the multiple medication violation point system prior to this ruling. The points assessed for this medication/prohibited substance violation are one (1) point, giving a total of one (1) point pursuant to section 178-1-49.3.m of the Thoroughbred Racing Rules.


