Industrial Laboratories reported sample #E584915 taken from the horse "Charlucito" which finished 1<sup>st</sup> in the 2<sup>nd</sup> race on Tuesday, May 14, 2024, did contain Methocarbamol confirmed in blood (4.6 ng/ml.) The measurement of uncertainty for the method is (0.16 ng/ml) at the (1 ng/ml) threshold. Methocarbamol is a class 4 drug carrying a C penalty.

Mr. Barbaran waived his right to a hearing and elected not to send a split sample. The Board of Stewards concludes that Mr. Barbaran has violated section 178-1-49.4.a.2 of the Thoroughbred Racing Rule, 178 C.S.R.1. This medication/prohibited substance violation is the permit holder's first violation in a 365-day period for medication/prohibited substance carrying a C penalty. The permit holder has accumulated (0) zero points under the multiple medication violation point system prior to this ruling. The points assessed for this medication/prohibited substance violation is one (1) point, giving a total of one (1) point pursuant to section 178-1-49.3.m of the Thoroughbred Racing Rules.

Based on the guidelines set forth in table 178-1 of the Thoroughbred Racing Rules, the Board of Stewards hereby fine Mr. Barbaran one thousand (\$1,000.00) dollars.


The horse "Chaelicito" is disqualified from all purse monies and the purse is to be redistributed as follows:

- 1<sup>st</sup>) Brazilian Sea
- 2<sup>nd</sup>) Mr Harry
- 3<sup>rd</sup>) Keto Friendly


The Stewards hereby impose the following penalty:

The Stewards hereby impose the following penalty:

Industrial Laboratories reported sample #E586474 taken from the horse "Perfect Moon" which finished 1<sup>st</sup> in the 1<sup>st</sup> race on Monday, May 20, 2024, did contain Methocarbamol confirmed in blood (2.47 ng/ml.) The measurement of uncertainty for the method is (0.17 ng/ml) at the (1 ng/ml) threshold. Methocarbamol is a class 4 drug carrying a C penalty.

Mr. Barbaran waived his right to a hearing and elected not to send a split sample. The Board of Stewards concludes that Mr. Barbaran has violated section 178-1-49.4.a.2 of the Thoroughbred Racing Rule, 178 C.S.R.1. This medication/prohibited substance violation is the permit holder's first violation in a 365-day period for medication/prohibited substance carrying a C penalty. Based on rule #178-1-49.3.m.4 of the Thoroughbred Rules of Racing, Multiple positive tests for the same medication incurred by a trainer prior to delivery of official notice by the Stewards or the Commission may be treated as a single violation.

The permit holder has accumulated (1) one point under the multiple medication violation point system prior to this ruling. The points assessed for this medication/prohibited substance violation is one-half (1/2) point, giving a total of one and one-half (1 1/2) points pursuant to section 178-1-49.3.m of the Thoroughbred Racing Rules.

Based on the guidelines set forth in table 178-1 of the Thoroughbred Racing Rules, the Board of Stewards hereby fine Mr. Barbaran one thousand (\$1,000.00) dollars.

The horse "Perfect Moon" is disqualified from all purse monies and the purse is to be redistributed as follows:





The measurement of uncertainty for the method is (0.31 ng/ml) at the (3 ng/ml) threshold. Phenylbutazone confirmed in blood at (1.08 pg/ml.) The measurement of uncertainty for the method is (0.05 pg/ml) at the (0.3 pg/ml) threshold. These two drugs constitute a category 3 NSAID Stacking Violation carrying a C penalty (fines only).


Ms. Pickett waived her right to a hearing and elected not to send a split sample. The Board of Stewards concludes that Trainer Crystal Pickett has violated section 178-1-49.6.c.3.a of the Thoroughbred Racing Rule, 178 C.S.R.1. This medication/prohibited substance violation is the permit holder's first violation in a 365-day period for medication/prohibited substance carrying a C penalty. The permit holder has accumulated (0) zero point under the multiple medication violation point system prior to this ruling. The points assessed for this medication/prohibited substance violation is one-half (1/2) point, giving a total of one-half (1/2) point pursuant to section 178-1-49.3.m of the Thoroughbred Racing Rules.

Based on the guidelines set forth in table 178-1 of the Thoroughbred Racing Rules, the Board of Stewards hereby fine Ms. Pickett one thousand (\$1,000.00) dollars.


