The Stewards hereby impose the following penalty:

A hearing was convened on Wednesday, January 15, 2025 for Owner/Trainer Wilfrido Montano regarding allegations that he had violated WV Rules of Racing #178-1-24.11.e, 178-1-24.11.q, and 178-1-24.11.gg. Multiple horses under Mr. Montano's care were severely malnourished without food, water, or medical treatment.


The Board of Stewards finds Mr. Montano to be in violation of the aforementioned rules and is hereby fined five thousand (\$5,000.00) dollars and his owner/trainer and authorized agents permits are revoked. Mr. Montano is permanently ineligible to hold a permit in West Virginia and is denied the grounds under the jurisdiction of the West Virginia Racing Commission.

All fines imposed by the stewards shall be paid to the Racing Commission within 7 days after the ruling is issued, unless otherwise ordered by the Stewards, per WV Rule of Racing number 178-1-8.5.n.

The Board of Stewards hereby impose the following penalty:

Industrial Laboratories reported sample #E530665 taken from the horse "Revocata" which finished 1st in the 4th race on Monday, November 18, 2024, did contain O-Desmethyldiamorphine confirmed in urine. A split sample was sent to the University of Kentucky which confirmed the presence of O-Desmethyldiamorphine. O-Desmethyldiamorphine is a class 2 drug carrying a B penalty.

A hearing was conducted on Tuesday, January 28, 2025, which Mr. Silva did attend and was represented by a representative from HBPA. After hearing all evidence and testimony, Mr. Silva is found to be in violation of WV Rules of Racing 178-1-49.4.a. and 178-1-49.4.a.1. of the Thoroughbred Racing Rule, 178 C.S.R.1. This medication/prohibited substance violation is the permit holder's first offense in a 365-day period for medication/prohibited substance carrying a B penalty. The permit holder has accumulated one-half (1/2) points under the multiple medication violation point system prior to this ruling. The points assessed for this medication/prohibited substance violation are four (4) points, giving a total of four and one-half (4 1/2) points pursuant to section 178-1-49.3.m of the Thoroughbred Racing Rules.


Based on the guidelines set forth in table 178-1 of the Thoroughbred Racing Rules, the Board of Stewards hereby fine Mr. Silva five hundred (\$500.00) dollars and suspend him for fifteen (15) days beginning Friday, February 7, 2025, through and including Friday, February 21, 2025. Mr. Silva is denied the privileges of the grounds under the jurisdiction of the WVRC.

The horse "Revocata" is disqualified from all purse monies and the purse is to be redistributed as follows:


