
“A rider who elects to use a riding crop, ... may **NOT**: Use the crop on the head, flank or other part of the horse other than the shoulder or hind quarters;”


Mr. Bocachica is hereby fined one hundred (\$100.00) dollars. This is his first offense at Mountaineer Park for 2025.
