

**FOLLOWING A STEWARDS HEARING WHICH WAS HELD ON WEDNESDAY, JULY 13, 2016 AT 11:00 am IN THE STEWARDS OFFICE FOR TRAINER EDDIE CLOUSTON. THE BOARD OF STEWARDS FIND MR. CLOUSTON IN VIOLATION OF WV RULE OF RACING: 178-4-49.3.m, 178-1-49.3.m.1, 178-1-49.3.m.7.A, 178-1-49.3.m.7.B, 178-1-49.4.a.2 AND 178-1-51.1.a.**

**THE OFFICIAL BLOOD SAMPLE #E204349 TAKEN FROM THE HORSE "SO FRANK" WHICH FINISHED SECOND(2) IN THE 5TH RACE ON SUNDAY, JUNE 12, 2016 DID CONTAIN "BETAMETHASONE" A CONTROLLED THERAPEUTIC MEDICATION WHICH IS A CLASS 4 DRUG CARRYING A C PENALTY AT A CONCENTRATION LEVEL OF 120 +/- pg/ml WHICH WAS CONFIRMED IN THE BLOOD. MR. CLOUSTON ELECTED NOT TO SEND A SPLIT SAMPLE.**

**A.) THE PERMIT HOLDER'S PAST RECORD.**

**MR. CLOUSTON HAD TWO (2) MEDICATION POSITIVES IN 2008 AND MULTIPLE "PHENYLBUTAZONE" OVERAGES PRIOR TO THE IMPLEMENTATION OF THE MULTIPLE MEDICATION VIOLATION SYSTEM. MR. CLOUSTON ALSO HAD A CLASS 4 POSITIVE "CARBAZOCHROME" IN 2015 GIVING HIM TWO POINTS (2) UNDER THE POINT SYSTEM. THIS IS MR. CLOUSTON'S FIRST (1) VIOLATION IN 2016 AND HIS SECOND (2) VIOLATION IN A 365 DAY PERIOD.**
