THE OFFICIAL BLOOD SAMPLE #E204076 TAKEN FROM THE HORSE "MYPENNYFROMHEAVEN" WHICH FINISHED 1ST IN THE 8TH RACE ON WEDNESDAY, AUGUST 3, 2016 DID CONTAIN "DEXAMETHASONE" A CONTROLLED THERAPEUTIC MEDICATION WHICH IS A CLASS 4 DRUG CARRYING A C PENALTY AT A CONCENTRATION LEVEL OF 17.5 pg/ml WHICH WAS CONFIRMED IN THE BLOOD. MR. WELSH ELECTED NOT TO SEND A SPLIT SAMPLE.
