
RULING NUMBER 101







RULING-MEDICATION VIOLATION

RULING: 106

TO: Owner/Trainer, Adam Ingram; Permit #20677 /SS# xxx-xx-5328

On July 15, 2016, the Board of Stewards offered a hearing regarding allegations set forth in a hearing notice to Trainer, Adam Ingram, to which he waived his right to a hearing, regarding the allegations set forth in Notice of Hearing issued on June 29, 2016.

After considering the evidence, the Board of Stewards hereby find the following:

The official blood/urine sample #196483 taken on 6/29/16 was reported by Industrial Laboratories, official testing laboratory, to contain Ketoprofen, which is a Class 4 drug, with a C Penalty designation. Sample #196483 contained 7.1 ng/ml of the drug, which is above the permissible threshold. The permissible threshold for Ketoprofen is 2 ng/ml. The sample was taken from the Six (6) horse, "Emotional Stroll", which ran in the Second Race on June 29, 2016, finishing First.

Owner/Trainer, Adam Ingram elected to waive his right to the split sample testing.

The Stewards conclude that Mr. Ingram has violated section(s) 178-1-51.1.a of the Thoroughbred Racing Rule, 178 W. Va. C.S.R.1. This medication/substance violation is the permit holders' First offense. The permit holder has accumulated 0 points under the multiple medication violation point system prior to this ruling. The points assessed for this medication/substance violation is 1 point pursuant to section 49.3.m. of 178 of W.Va.C.S.R.1. This penalty is in addition to the penalty imposed by the stewards for the underlying offense.

The Penalty Guidelines set forth in Table 178-1 E of the Thoroughbred Racing Rules provide a minimum penalty of Written Warning and a maximum penalty of \$500.00 fine, for the underlying offense, on a case by case basis, by considering mitigating and aggravating factors.

The following is the stewards' analysis of the mitigation/factors in this matter:

- A.) **(Mitigating)** The Permit holder's past record **No Rule Violations**
- B.) **(Aggravating)** The Potential of the drug to influence the horse's racing performance:

- F.) **(Aggravating)** The probability of environmental contamination exposure due to human use: **N/A**
- G.) **(Mitigating)** The purse of the race: **N/A**
- H.) **(Aggravating)** Whether the drug found was one for which the horse was receiving a treatment as documented by the treating veterinarian's treatment record. **Horse was being treated.**

- I.) **(Mitigating)** Whether there was any suspicious betting pattern in the race: **N/A**
- J.) **(Mitigating)** Whether the trainer was acting under the advice of a veterinarian licensed to practice in West Virginia and holding an occupational permit issued by the Racing Commission. **Yes**
- K.) Others factors deemed relevant by the Stewards: **N/A**


Based on the above, the Board of Stewards hereby impose the following penalty for the underlying offense: **Mr. Ingram** will be fined **\$250.00**, and the additional penalty of **1 point** under the multiple violation point system, for a total penalty of **1 point**.

"Emotional Stroll" is **not disqualified** from a **First place** finish.





During the stretch run in the **Eighth Race, Thursday, July 14, 2016**, Perez's mount "**Diamond Causeway**" swerved in while having the riders' crop applied and caused interference to "**Half a Bushel**".

His mount was **disqualified** from **Sixth** position and placed **Eighth**.





His mount was disqualified from **Fourth position** and placed **Sixth**.

RULING-MEDICATION VIOLATION

RULING: 112

TO: Trainer, Brenda M. Godfrey; Permit #12327 /SS# xxx-xx-7426

On July 30, 2016, the Board of Stewards offered a hearing regarding allegations set forth in a hearing notice to Trainer, Brenda Godfrey, to which she waived her right, regarding the allegations set forth in Notice of Hearing issued on July 29, 2016.

After considering the evidence, the Board of Stewards hereby find the following:

The official blood/urine sample #196550 taken on 7/09/16 was reported by Industrial Laboratories, official testing laboratory, to contain Meclofenamic Acid, which is a Class 4 drug, with a C Penalty designation. Sample #196550 contained 2.6 ng/ml of the drug; there is no permissible threshold for Meclofenamic Acid. The sample was taken from the Two (2) horse, "Strength and Honor", which ran in the Second Race on July 9, 2016, finishing First.

The official blood/urine sample #196550 taken from "Strength and Honor" was also found to have Naproxen, which is a Class 4 drug, with a C Penalty designation. Sample #196550 contained 26.4 ng/ml. There is no permissible threshold for Naproxen.

Trainer, Brenda Godfrey elected to waive her right to the split sample testing.

The Stewards conclude that Ms. Godfrey has violated section(s) 178-1-51.1.a of the Thoroughbred Racing Rule, 178 W. Va. C.S.R.1. This medication/substance violation is the permit holders' 1st and 2nd offense for a medication/substance violation carrying a Category C penalty. The permit holder has accumulated 0 points under the multiple medication violation point system prior to this ruling. The points assessed for this medication/substance violation is 4 points pursuant to section 49.3.m. of 178 of W.Va.C.S.R.1. This penalty is in addition to the penalty imposed by the stewards for the underlying offense.

The Penalty Guidelines set forth in Table 178-1 E of the Thoroughbred Racing Rules provide a minimum penalty of \$2500.00 fine, Loss of Purse and a 15 day suspension for the underlying offense. However, the Stewards determine the appropriate penalty for the underlying offense on a case by case basis by considering mitigating and aggravating factors.

The following is the stewards' analysis of the mitigation/factors in this matter:

- A.) **(Mitigating)** The Permit holder's past record **No Rule Violations**
- B.) **(Aggravating)** The Potential of the drug to influence the horse's racing performance: **May influence performance**
- C.) **(Aggravating)** The legal availability of the drug: **Is Widely Available**
- D.) **(Mitigating)** Whether there is reason to believe the permit holder knew of the administration of the drug or intentionally administered the drug. **Permit Holder Knew**

Based on the above, the Board of Stewards hereby impose the following penalty for the underlying offense: **Ms. Godfrey** will be fined **\$2500.00**, and the additional penalty of **4 points** under the multiple violation point system, for a total penalty of **4 points**, which carries an additional **30 day suspension** over and above the **15 days** given for the drug violation. The days will run consecutively from **Saturday, July 30, 2016 through and including Monday, September 12, 2016**.





On July 29, 2016, the Board of Stewards offered a hearing regarding allegations set forth in a hearing notice to Trainer, Eddie Householder, to which he waived his right, regarding the allegations set forth in Notice of Hearing issued on July 29, 2016.

After considering the evidence, the Board of Stewards hereby find the following:

The official blood/urine sample #196552 taken on 7/09/16 was reported by Industrial Laboratories, official testing laboratory, to contain Dexamethasone, which is a Class 4 drug, with a C Penalty designation. Sample #196552 contained 25.5 pg/ml of the drug; the permissible threshold for Dexamethasone is 5 pg/ml. The sample was taken from the Seven (7) horse, "Romantikus", which ran in the Second Race on July 9, 2016, finishing Sixth.

Trainer, Eddie Householder elected to waive his right to the split sample testing.

The Stewards conclude that Mr. Householder has violated section(s) 178-1-51.1.a of the Thoroughbred Racing Rule, 178 W. Va. C.S.R.1. This medication/substance violation is the permit holders' 1st offense for a medication/substance violation carrying a Category C penalty. The permit holder has accumulated 0 points under the multiple medication violation point system prior to this ruling. The points assessed for this medication/substance violation is 1 point pursuant to section 49.3.m. of 178 of W.Va.C.S.R.1. This penalty is in addition to the penalty imposed by the stewards for the underlying offense.

The Penalty Guidelines set forth in Table 178-1 E of the Thoroughbred Racing Rules provide a minimum penalty of \$1000.00 fine, Loss of Purse. However, the Stewards determine the appropriate penalty for the underlying offense on a case by case basis by considering mitigating and aggravating factors.
