



The Stewards hereby impose the following penalty:

Jockey Edgar Paucar is hereby suspended seven (7) days effective Thursday, June 1, 2017 through and including Wednesday, June 7, 2017 for violation of WV RULE of RACING #178-1-45-7.B.1. "A jockey shall not ride carelessly or willfully so as to permit his or her mount to interfere with, impede or intimidate any other horse in the race." After review of the race in the jocks room with Edgar Paucar being represented by jockey "Chad Murphy," the Board of Stewards determined that #5, "Mr Ree" ridden by Edgar Paucar caused interference in the stretch run to #1, "Meregon" during the running of the second race on Wednesday, May 24, 2017. Edgar Paucar's mount, "Mr Ree" was disqualified from first and placed second for interference. While suspended Edgar Paucar may gallop as per WV Rule of Racing 178-1-28.1.f. All fines are to be paid within (7) days of imposition as per WV RULE of RACING #178-1-8.5.N.


The Stewards hereby impose the following penalty:

THE SAMPLE WAS QUANTITATED AT A LEVEL OF 3.8 ug/ml.

THIS IS MR. DIXON'S FIRST OFFENSE AND HE IS ASSIGNED 1/2 POINT FOR THE MULTIPLE MEDICATION VIOLATION SYSTEM.

You have the right to appeal this ruling to the Racing Commission. Your appeal must be received in the Commission Office within 20 days of your receipt of the ruling and must include a security fee in the amount of \$500.00.
