The Stewards hereby impose the following penalty:

Having waived his right to a hearing, trainer Frank Gerich, the board of Stewards find Mr. Gerich in violation of WV Rule of Racing 178-1-49.4.a.2.

"Controlled therapeutic medications in excess of established threshold concentrations as set forth in the Association of Racing Commissions International Controlled Therapeutic Medication Schedule, Version 2.1, contained in table 178-1F."

The official blood and urine samples' #E218629 taken from the horse "CanaryInacoalmine," which finished 1st in the 6th race on 6/18/2017, did contain Dexamethasone above the accepted threshold at a concentration level of 109.2 pg/ml. Dexamethasone is a controlled class 4 therapeutic medication carrying a C penalty.

This is Mr. Gerich's first medication violation and is assigned 1/2 point for the multiple medication violation system. Mr. Gerich declined to send a split sample.

The following is the Stewards' analysis of the mitigating/aggravating factors in the matter:

A. The permit holder's past record.

This is his first offense.

B. The potential of the drug to influence the horse's performance.

Class 4 drugs generally have a more limited ability to influence the performance of a racehorse.

C. The legal availability of the drugs.

Legally available.

D. Whether there is reason to believe the permit holder knew of the administration or intentionally administered the drug.

E. The steps taken by the trainer to safeguard the horse.

F. The probability of environmental contamination or inadvertent exposure due to human drug use.




The Hearing will be held on Saturday, July 22, 2017
