

The Stewards hereby impose the following penalty:

On Tuesday, February 20, 2018 the Board of Stewards conducted a hearing regarding allegations set forth in a notice of hearing issued January 18, 2018. After considering the evidence, the Board of Stewards hereby find the following:

The official blood and urine sample number E219143 taken from the horse "Clearly Dreamin," which finished 2nd in the 4th race on September 11, 2017 did contain Lamotrigine confirmed in serum (approximately 1.2 ng/ml) and Topiramate (approximately 2.2 ng/ml) confirmed in serum. Lamotrigine is a class 3 drug carrying an A penalty and Topiramate is a class 2 drug carrying an A penalty. A split sample was sent to The University of California, Davis, which confirmed the presence of Topiramate and Lamotrigine.

The Board of Stewards conclude that Mr. Martin has violated sections 178-1-49.4a and 178-1-178-49.2.a of the Thoroughbred Racing Rule, 178 C.S.R.1. This medication/prohibited substance violation is the permit holder's 1st offense for a medication/substance violation carrying a category A penalty. The permit holder has accumulated 0 (zero) points under the multiple medication violation point system prior to this ruling. The points assessed for this medication/substance violation are 6 (six) pursuant to section 178-1-49.3.m of the Thoroughbred Racing Rules.

The penalty guidelines set forth in table 178-1 E of the Thoroughbred Racing Rules provide a minimum penalty of 1 (one) year suspension and a \$10,000 (ten thousand dollar) fine absent mitigating circumstances and a maximum penalty of a 3 (three) year suspension and a \$25,000 (twenty-five thousand dollar) fine with the presence of aggravating factors.

Based on the above, the Board of Stewards hereby fine Mr. Martin \$7,500 (seven thousand five hundred dollars.) The fine shall be paid within 7 (seven) calendar days after this ruling is issued.

The following is the Stewards' analysis of the mitigating/aggravating factors in this matter:

- A.) **The permit holder's past record**
The trainer has had one Phenylbutazone positive in the past 2 years.
- B.) **The potential of the drug to influence the horse's racing performance**
Drugs in this class may or may not have an accepted therapeutic use in the horse. Many are drugs that affect the cardiovascular, pulmonary and autonomic nervous systems. They all have the potential of affecting the performance of a racehorse.
- C.) **The legal availability of the drug**
Legal by prescription
- D.) **Whether there is a reason to believe the permit holder knew of the administration of the drug or intentionally administered the drug**
Trainer says he has no knowledge of the drug.
- E.) **The steps taken by the trainer to safeguard the horse**
Trainer ships horse in from the farm to run. No extraordinary steps to safeguard the horse.
- F.) **The probability of environmental contamination or inadvertent exposure due to human drug use**
There is a possibility
- G.) **The purse of the race**
\$6,100 (six thousand one hundred dollars)
- H.) **Whether the drug found was one for which the horse was receiving a treatment as documented by the treating veterinarian's treatment records.**
The horse was not being treated by a veterinarian for this drug
- I.) **Whether there was any suspicious betting pattern in the race.**
None
- J.) **Whether the trainer was acting under the advice of a veterinarian licensed to practice in West Virginia and holding an occupational permit issued by the Racing Commission.**
The trainer denies any administration of this drug
- K.) **Other factors deemed relevant by the Stewards.**
The trainer has established a very respectful training career for 18 years with no major medication violations. The trainer has had one class C positive of Phenylbutazone in the past 2 years.

The horse "Clearly Dreamin" is disqualified from all purse monies and the purse is to be redistributed as follows:



On Tuesday, March 20, 2018 the Board of Stewards conducted a hearing regarding allegations set forth in a notice of hearing issued January 18, 2018. After considering the evidence, the Board of Stewards hereby find the following:

Industrial Laboratories reported the official sample #E233763 taken from the horse "Indygo Tigress" which finished 1st in the 6th race on November 7, 2017 did contain Mitragnine confirmed in serum (3.66 ng/ml), Mitragnine (3.2 ng/ml) and 7-Hydroxymitragnine (1.2 ng/ml) confirmed in urine. This drug is not listed in the guidelines but racing rule 178CSR1 states substances not listed should be treated as class 1 violation warranting a class A penalty. The Board of Stewards conclude that Mr. Welsh has violated sections 178-1-49.4.a, 178-1-51.1.a, 178-1-49.4 and 178-1-49.a.1 of the Thoroughbred Racing Rule 178CSR1. This medication/prohibited substance violation is the permit holder's 1st offense for a medication/substance violation carrying a category A penalty. The permit holder has accumulated 0 (zero) points under the multiple medication violation point system prior to this ruling. The points assessed for this medication/substance violation are 6 (six) pursuant to section 178-1-49.3.m of the Thoroughbred Racing Rules.

The penalty guidelines set forth in table 178-1-E of the Thoroughbred Racing Rules provide a minimum penalty of 1 (one) year suspension and a \$10,000 (ten thousand dollar) fine absent mitigating circumstances and a maximum penalty of 3 (three) year suspension and a \$25,000 (twenty five thousand dollar) fine with the presence of aggravating factors.

Based on the above, the Board of Stewards hereby fine Mr. Welsh \$2,500 (two thousand five hundred dollars) and suspend his permit for 30 (thirty) days effective Tuesday, April 3, 2018 through and including Wednesday, May 2, 2018. The fine shall be paid within 7 (seven) calendar days after this ruling is issued.

The horse "Indygo Tigress" is disqualified from all purse monies and the purse is to be redistributed as follows:

1st Her Case of Gold

2nd Ghetto Fabulous

3rd Surfin' Bird

4th My Angel My Saint

5th Midnight Leap

6th Charlie's Angel

The horseman's bookkeeper is requested to make the necessary adjustments.

The following is the Stewards' analysis of the mitigating/aggravating factors in this matter:

A.) The permit holder's past record

Mr. Welsh had 2 (two) class C medication violations in 2016.

B.) The potential of the drug to influence the horse's racing performance

Drugs in this class may or may not have an accepted therapeutic use in the horse. Many are drugs that affect the cardiovascular, pulmonary and autonomic nervous systems. They all have the potential of affecting the performance of a racehorse.

C.) The legal availability of the drug

This substance was purchased legally as Kratom.

D.) Whether there is a reason to believe the permit holder knew of the administration of the drug or intentionally administered the drug

Mr. Welsh denies he gave the horse the substance, but stated after learning he had a positive, his groom admitted that he had given the horse Kratom with his feed.

E.) The steps taken by the trainer to safeguard the horse

Unknown

F.) The probability of environmental contamination or inadvertent exposure due to human drug use

The groom stated that he uses this substance for pain

G.) The purse of the race

H.) Whether the drug found was one for which the horse was receiving a treatment as documented by the treating veterinarian's treatment records.
