



The Stewards hereby impose the following penalty:

Having waived his right to a hearing, trainer Rafael Ramos is hereby found to be in violation of WV Rule of Racing 178-1-49.4.a.2.

Industrial Laboratories reported sample E284776 taken from the horse "Mr. Steam" which finished 2nd in the 1st race on Tuesday, June 4, 2019 did contain Aminocaproic Acid confirmed in blood (approximately 6.94 ug/ml.) Aminocaproic Acid is a class 4 drug carrying a C penalty. Mr. Ramos elected not to send a split sample.

The Board of Stewards concludes that Mr. Ramos has violated section 178-1-49.4.a.2 of the Thoroughbred Racing Rule, 178 C.S.R.1. This medication/prohibited substance violation is the permit holders 2nd offense in a 365 day period for a medication/substance violation carrying a C penalty. The permit holder has accumulated 0 (zero) points under the Multiple Medication Violation point system prior to this ruling. The points assessed for this medication/substance violation are 1 (one) points pursuant to section 178-1-49.3m of the Thoroughbred Racing Rules.

Based on the guidelines set forth in table 178-1 of the Thoroughbred Racing Rules, the Board of Stewards hereby fine Mr. Ramos one thousand dollars (\$1,000.00.)

The horse "Mr. Steam" is disqualified from all purse monies and the purse is to be redistributed as follows:

1st) Modern Medicine

2nd) Feet's Afire

3rd) Romeo Royale

4th) Far's Chief

5th) Majestic Desert

6th) Determined


7th) Aggravator

8th) Victory Slide
