Industrial Laboratories reported sample #E338630 taken from the horse "Pure Moment" which finished 1st in the 9th race on Wednesday, August 19, 2020 did contain Naproxen confirmed in blood. Naproxen is a class 4 drug carrying a C penalty.

Mr. Zircher waived his right to a hearing and elected not to send a split sample. The Board of Stewards concludes that Mr. Zircher has violated section 178-1-49.4.a.1 of the Thoroughbred Racing Rule, 178 C.S.R.1. This medication/prohibited substance violation is the permit holders first violation in a 365-day period for medication/prohibited substance carrying a C penalty. The permit holder has accumulated (0) zero points under the multiple medication violation point system prior to this ruling. The points assessed for this medication/prohibited substance violation are (1) one, giving a total of (1) one points pursuant to section 178-1-49.3.m of the Thoroughbred Racing Rules.

Based on the guidelines set forth in table 178-1 of the Thoroughbred Racing Rules, the Board of Stewards hereby fine Mr. Zircher one thousand (\$1,000.00) dollars

The horse "Pure Moment" is disqualified from all purse monies and the purse is to be redistributed as follows:

- 1st) Tapizar King
- 2nd) White Russian
- 3rd) Waltersram
- 4th) Jerry the Bull
- 5th) Perfectly Plain
- 6th) Desert Frontier
- 7th) Mecke's Dynasty

The horseman's bookkeeper is requested to make the necessary adjustments.
