
Industrial Laboratories reported sample #E479442 taken from the horse "Black Kettle" which finished 3rd in the 1st race on Sunday, June 12, 2022, did contain Flunixin confirmed in blood (55.4 ng/ml.) The measurement of uncertainty for the method is (3 ng/ml) at the (20 ng/ml) threshold. Flunixin is a class 4 drug carrying a C penalty.

Mr. Spiess waived his right to a hearing and elected not to send a split sample. The Board of Stewards concludes that Mr. Spiess has violated section 178-1-49.4.a.2 of the Thoroughbred Racing Rule, 178 C.S.R.1. This medication/prohibited substance violation is the permit holder's first offense in a 365-day period for medication/prohibited substance carrying a C penalty. The permit holder has accumulated zero (0) points under the multiple medication violation point system prior to this ruling. The points assessed for this medication/prohibited substance violation are one-half (1/2) point, giving a total of one-half (1/2) point pursuant to section 178-1-49.3.m of the Thoroughbred Racing Rules.


