Industrial Laboratories reported sample #E480219 taken from the horse "Love Twenty Six" which finished 1<sup>st</sup> in the 8<sup>th</sup> race on Sunday, October 2, 2022, did contain Flunixin confirmed in blood (10.8 ng/ml.) The measurement of uncertainty for the method is (0.5 ng/ml) at the (3 ng/ml) threshold and Phenylbutazone confirmed in blood at (0.697 ug/ml.) These two drugs are above the accepted threshold which constitutes a class 3 NSAID Stacking Violation with a C penalty.


The permit holder has accumulated (0) zero points under the multiple medication violation point system prior to this ruling. The points assessed for this medication/prohibited substance violation are one-half (1/2) point, giving a total of one-half (1/2) point pursuant to section 178-1-49.3.m of the Thoroughbred Racing Rules.

The Stewards hereby impose the following penalty:

Industrial Laboratories reported sample #E479823 taken from the horse "Holiday Bonus" which finished 1<sup>st</sup> in the 2<sup>nd</sup> race on Monday, August 8, 2022 did contain 3-Hydroxylidocaine confirmed in blood at (829 pg/ml.) The measurement of uncertainty for the method is (3 pg/ml) at the (20 pg/ml) threshold. 3-Hydroxylidocaine is a class 2 drug carrying a B penalty.

Mr. Fairman elected to send a split sample. The split sample E479823 was sent to Texas A&M Veterinary Medical Diagnostic Laboratory, College Station, Texas. 3-Hydroxylidocaine was detected in the sample by LC-MS/MS at the concentration of (822.8 pg/ml.) The Board of Stewards concludes that Mr. Fairman has violated section 178-1-49.4.a.2 of the Thoroughbred Racing Rule, 178 C.S.R.1. This medication/prohibited substance violation is the permit holder's first violation in a 365-day period for medication/prohibited substance carrying a B penalty.

The permit holder has accumulated (0) zero points under the multiple medication violation point system prior to this ruling. The points assessed for this medication/prohibited substance violation are two (2) points, giving a total of two (2) points pursuant to section 178-1-49.3.m of the Thoroughbred Racing Rules.

Based on the guidelines set forth in table 178-1 of the Thoroughbred Racing Rules, the Board of Stewards hereby fine Mr. Fairman five hundred (\$500.00) dollars and suspend him for fifteen (15) days. Suspension shall start Sunday, October 30, 2022, through and including Monday, November 14, 2022.

The Stewards hereby impose the following penalty:

Industrial Laboratories reported sample #E480267 taken from the horse "Parade Grand" which finished 4<sup>th</sup> in the 1<sup>st</sup> race on Wednesday, October 19, 2022 did contain Flunixin confirmed in blood (91.4 ng/ml.) The measurement of uncertainty for the method is (2.7 ng/ml) at the (20 ng/ml) threshold. Flunixin is a class 4 drug carrying a C penalty.

Mr. Clouston waived his right to a hearing and elected not to send a split sample. The Board of Stewards concludes that Mr. Clouston has violated section 178-1-49.4.a.2 of the Thoroughbred Racing Rule, 178 C.S.R.1. This medication/prohibited substance violation is the permit holder's first violation in a 365-day period for medication/prohibited substance carrying a C penalty. The permit holder has accumulated (0) zero points under the multiple medication violation point system prior to this ruling. The points assessed for this medication/prohibited substance violation are one-half (1/2) point, giving a total of one-half (1/2) point pursuant to section 178-1-49.3.m of the Thoroughbred Racing Rules.

Based on the guidelines set forth in table 178-1 of the Thoroughbred Racing Rules, the Board of Stewards hereby fine Mr. Clouston two hundred fifty (\$250.00) dollars.

All fines are to be paid within seven (7) days of imposition as per West Virginia Rule of Racing  
178-1-8.5.N.
