The Stewards hereby impose the following penalty:

Industrial Laboratories reported sample #E480722 taken from the horse "Papa Charles" which finished 1<sup>st</sup> in the 1<sup>st</sup> race on Wednesday, December 7, 2022, did contain Triamcinolone Acetonide confirmed in blood at (195 pg/ml). The measurement of uncertainty of the method is 21 pg/ml at the threshold of 100 pg/ml. Triamcinolone Acetonide is a class 4 drug carrying a C penalty.

Mr. Gotera waived his right to a hearing and elected not to send a split sample. The Board of Stewards concludes that Mr. Gotera has violated section 178-1-49.4.a.2 of the Thoroughbred Racing Rule, 178 C.S.R.1. This medication/prohibited substance violation is the permit holder's 1<sup>st</sup> offense in a 365- day period for multiple medication/prohibited substance carrying a C penalty.

The permit holder has accumulated zero (0) points under the multiple medication violation point system prior to this ruling. The points assessed for this medication/prohibited substance violation are one-half (1/2) giving a total of one-half (1/2) point pursuant to section 178-1-49.3.m of the Thoroughbred Racing Rules.

Based on the guidelines set forth in table 178-1 of the Thoroughbred Racing Rules, the Board of Stewards hereby fine Mr. Gotera one thousand (\$1,000.00) dollars.


The horse "Papa Charles" is disqualified from all purse monies and the purse is to be redistributed as follows:

- 3<sup>rd</sup>) Trust Fund Robber


The horseman's bookkeeper is requested to make the necessary adjustments.
