

After considering the evidence, the Judges hereby find the following:


A hearing was held for Kelsey Willard (which she chose not to attend) and was found guilty of assaulting Aubrey Derr.



On _____, the Board of Judges conducted a hearing regarding allegations set forth in Notice of Hearing issued April 24, 2021


After considering the evidence, the Judges hereby find the following:


After considering the evidence, the Judges hereby find the following:
