
After considering all testimony and evidence, the Board of Stewards concludes the following:

Mr. Serrano violated section(s) 178-1-24.11.gg, 178-1-24.11.e and 178-1-24.11.d of the Thoroughbred Racing Rules. 178 C.S.R.1.

Mr. Serrano is suspended for 60 (sixty) days and must make restitution to Adrian Flores in the amount of \$724.28 (seven hundred twenty four dollars and twenty eight cents) within 14 (fourteen) days of this ruling. Failure to make restitution in this time frame will result in Mr. Serrano having his racing permit revoked at the end of the 60 (sixty) day suspension. The suspension shall start on Thursday, January 24, 2019 through and including Sunday, March 24, 2019.
