Industrial Laboratories reported sample #E698454 taken from the horse "Saweeetie Girl" which finished 1st in the 3rd race on Tuesday, September 16, 2025, did contain Methocarbamol confirmed in blood (1.24 ng/ml.) Methocarbamol is a class 4 drugs carrying a C penalty.

Mr. Gotera waived his right to a hearing and elected not to send a split sample. The Board of Stewards concludes that Mr. Gotera has violated section 178-1-49.4.a.2 of the Thoroughbred Racing Rule, 178 C.S.R.1. This medication/prohibited substance violation is the permit holder's second violation in a 365-day period for medication/prohibited substance carrying a C penalty. The permit holder has accumulated zero (0) points under the multiple medication violation point system prior to this ruling. The points assessed for this medication/prohibited substance violation is one (1) point, giving a total of one (1) point pursuant to section 178-1-49.3.m of the Thoroughbred Racing Rules.

Based on the guidelines set forth in table 178-1 of the Thoroughbred Racing Rules, the Board of Stewards hereby fine Mr. Gotera one thousand (\$1,000.00) dollars.
