
The Stewards hereby impose the following penalty:


Mr. Bowen is hereby fined two hundred (\$200.00) dollars.




Mr. Oliveros is hereby fined two hundred (\$200.00) dollars.


The Board of Stewards hereby impose the following penalty:

Trainer Jami Poole is hereby fined two hundred fifty (\$250.00) dollars for violation of WV Rule of Racing 178-1-26.3.g.


Mr. Poole scratched the horse "The Shoe Lady" which was scheduled to run in the 7th race on Sunday, May 31, 2026.
