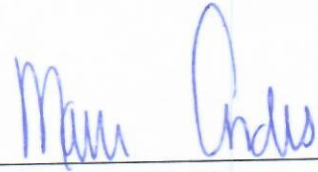
The Stewards hereby impose the following penalty:

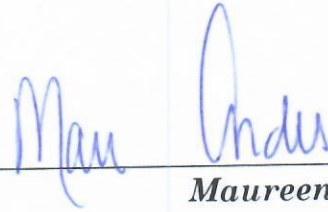

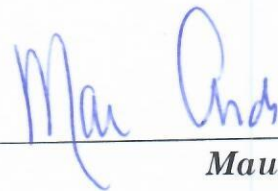

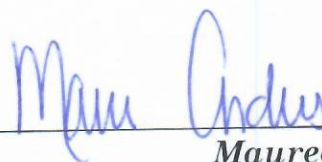
The Stewards hereby impose the following penalty:

The Stewards hereby impose the following penalty:

Industrial Laboratories reported sample #E702676 taken from the horse "Ninety Two" which finished 1st in the 8th race on Monday, June 29, 2026, did contain Dimethyl Sulfoxide confirmed in blood (22.4 pg/ml.) Dimethyl Sulfoxide is a class 4 drugs carrying a C penalty.

Mr. Brown waived his right to a hearing and elected not to send a split sample. The Board of Stewards concludes that Mr. Brown has violated section 178-1-49.4.a.2 of the Thoroughbred Racing Rule, 178 C.S.R.1. This medication/prohibited substance violation is the permit holder's second violation in a 365-day period for medication/prohibited substance carrying a C penalty. The permit holder has accumulated one-half (1/2) points under the multiple medication violation point system prior to this ruling. The points assessed for this medication/prohibited substance violation is one-half (1/2) point, giving a total of one (1) point pursuant to section 178-1-49.3.m of the Thoroughbred Racing Rules.

After taking into consideration mitigating circumstances and based on the guidelines set forth in table 178-1 of the Thoroughbred Racing Rules, the Board of Stewards hereby fine Mr. Brown one thousand five hundred (\$1,500.00) dollars.

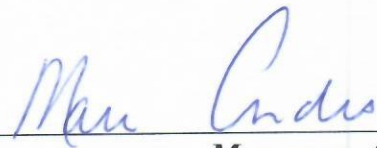

This medication/prohibited substance violation is the permit holder's second stacking violation in a 365-day period for medication/prohibited substance carrying a C penalty. The permit holder has accumulated one (1) point under the multiple medication violation point system prior to this ruling. The points assessed for this medication/prohibited substance violation is one-half (1/2) point, giving a total of one and one-half (1½) points pursuant to section 178-1-49.3.m of the Thoroughbred Racing Rules.

Based on the guidelines set forth in table 178-1 of the Thoroughbred Racing Rules, the Board of Stewards hereby fined Mr. Brown seven hundred fifty (\$750.00) dollars.

All fines imposed by the stewards shall be paid to the Racing Commission within 7 days after the ruling is issued, unless otherwise ordered by the Stewards, per WV Rule of Racing number 178-1-8.5.n.

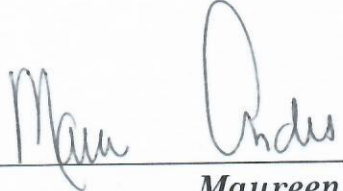

Industrial Laboratories reported sample #E702472 taken from the horse "Shoppingatbloomies" which finished 3rd in the 4th race on Tuesday, July 28, 2026, did contain Ractopamine confirmed in urine.

Ractopamine is a class 2 drugs carrying an A penalty.

Mr. Ramos waived his right to a hearing and elected not to send any split samples. The Board of Stewards concludes that Mr. Ramos has violated section 178-1-49.4.a.1 of the Thoroughbred Racing Rule, 178 C.S.R.1. This medication/prohibited substance violation is the permit holder's first violation in a 365-day period for medication/prohibited substance carrying an A penalty. The permit holder has accumulated zero (0) points under the multiple medication violation point system prior to this ruling. The points assessed for this medication/prohibited substance violation are six (6) points, giving a total of six (6) points pursuant to section 178-1-49.3.m of the Thoroughbred Racing Rules. Per WV Rules of Racing 178-1-49.3.m.4. "Multiple positive tests for the same medication incurred by a trainer prior to delivery of official notice by the stewards or the Commission may be treated as a single violation."

Based on the guidelines set forth in table 178-1-E of the Thoroughbred Racing Rules, the Board of Stewards hereby fine Mr. Ramos ten thousand (\$10,000.00) dollars. Mr. Ramos is suspended for one (1) year, beginning Wednesday, August 19, 2026, through and including Thursday, August 19, 2027. All three horses shall be placed on the veterinarian's list for one hundred eighty (180) days and must pass a Commission approved examination before becoming eligible to be entered.

The horse "Monje Solaia" is disqualified from all purse monies, and the purse is to be redistributed as follows:
